1. CALL TO ORDER

The meeting was called to order at 1307 hours.

L. Cullen introduced Susan Smith, the new Edco secretary in the Division Chairs Office.

4. CURRICULUM

L. Cullen turned the chair over to M. Heldman

4.a) FINANCIAL MANAGEMENT

Discontinued Course

i) FMGT 1285 – Financial Accounting

L. Cullen explained that this course discontinuation is effectively a housekeeping process, as the course has not been offered in a number of years and the discontinuation will be effective this semester (200620). The department has no plans to offer this course in the future.

4.b) NUTRITION & FOOD SERVICES MGT.

Description Change

- i) FSRV 2329 Food Service Supervision Practicum
- ii) FSRV 2529 Food Service Final/Clinical Field Work Practicum

L. Cullen explained that students require more time in the orientation and training in FSRV 2329 and less time in FSRV 2529, to complete the program competency requirements. The original total of 5 weeks will remain the same, but the allocation of time will be reversed, so that students will now complete a minimum of 15 days in the first segment of this practicum, and 10 days in the second. The changes are to take place in 200720.

4.c) BIOLOGY

Prerequisite Change

- G. Krause explained that the proposed English requirement will ensure that students, who are not already in the Nursing Program, will be competent in English, thereby encouraging student success.

- W. Low explained that NURS 1102 does not provide a seamless admission for Licensed Practical Nurses (LPN) to access the Bachelor of Science in Nursing Program, however this will be achieved through the proposed new Licensed Practical Nurse Transition (LPNT) Program and NURS1103, which will replace NURS 1102 which is discontinued.

L. Arnold clarified the terminology used to describe a collection of courses, (such as the LPNT) which, while often described as a program, and may lead students to access a higher level of courses, does not in itself award any credential. A brief discussion ensued, with the recommendation that the wording in this proposal under the section "Type of Credential to be Awarded", be changed to read: "Bridging Program – No Credential Awarded".

5. INFORMATION ITEMS

- i) CCAP Program update
 - M. Gerson explained that due to low enrolment levels, the College and Career Access Program has been suspended, and while it has not yet officially been discontinued, it is not expected to be offered beyond this term. In the meantime any students seeking related information will be directed to Counseling services.
- ii) Communicating changes and new initiatives approved by Education Council "Filling the Gap"
 - J. Hooton informed the Education Council of the new technical capacity to update the calendar and show curriculum related changes approved by Education Council. Previously, whenever changes were made there had been no method of communicating to students that those changes had occurred. It is now possible to click one button to view changes that have been made, and another to show changes yet to come. There was a short discussion related to the need to develop principles for using the technology, in particular to avoid confusing students with unexpected changes.
