Course Description, Prerequisites, and Corequisites:

In this capstone course, students create business plans for their own creative industries businesses. Working within provincial and municipal regulations and applying principles of project management, each student writes a comprehensive plan covering all major areas of the business including marketing, operations, and business finances. They also take the initial steps needed to start a business. Registration in this course is restricted to students admitted to the following programs: Diploma in Design Formation, Diploma in Fine Arts, Diploma in Professional Photography, Diploma in Publishing, and Certificate in Film Arts.
